4.a. Economic Policy

This module interrogates economic policies and their influence on local economic development. It locates economic policy in a sustainable livelihoods framework. Students will gain exposure to a wide range of recent economic trends in South Africa and the region, and identify overarching themes and concepts and their relationship to development.

4.b. Economic Practice (part of independent study/research project)

This module is intended to provide practical experience in economic development. Students will identify and analyse a local economic development project and critically evaluate the initiative based on ideas and concepts developed in the economic policy module.

5.a. Culture and Environmental Policy (16 credits)

This module identifies the ways in which culture relates to development in a local and global context. It examines questions such as power, values, attitudes, practices and their relationship to community development. It presents an analysis of culture within the South African context.

5.b. Culture and Environmental Practice (part of independent study/research project)

This practice module provides an opportunity to examine community development from the perspective of culture. Students identify a community and attempt to understand its cultural values and attitudes, and their relationship to development internally and externally.

6.a. Development Policy

This module examines the development of policy and how it relates to attitudes, agendas, global and local influences. It further identifies how policy is implemented and its purpose subordinated to influences

6.b. Development Policy Practice (part of independent study/research project)

This practice module allows students to study a particular policy in depth and make recommendations as to how it should be modified in terms of definition or application.

7. Independent Study (PGD)

To implement a project that demonstrates the ability to design, plan and manage a community development intervention. Students work in project groups, in conjunction with service
